

Summary of 2025 amendments to Annex I to Regulation (EU) 2021/821

OVERVIEW

The amendments reflect decisions and commitments by Member States taken within the framework of the multilateral export control regimes and export control arrangements Wassenaar Arrangement (WA), Missile Technology Control Regime (MTCR), Australia Group (AG) and Nuclear Suppliers Group (NSG). There are also a number of editorial amendments.
